Gulfport Police Department conducted a round-up of wanted drug suspects on Friday morning, August 20, 2010. These 18 wanted individuals were part of over 100 drug dealers being sought across the Mississippi Gulf Coast.

Operation Coastal Clean-up resulted from the collaboration of the Narcotics Task Force of Jackson County, the Mississippi Bureau of Narcotics, The Harrison County Sheriff's Office, The Biloxi Police Department Special Crimes Division, and the Gulfport Police Department Narcotics Unit.

In early 2010, coastal narcotics units came together to put forth a combined effort utilizing undercover officers. As a result of the operation the Gulfport Police Department arrested the following persons.
